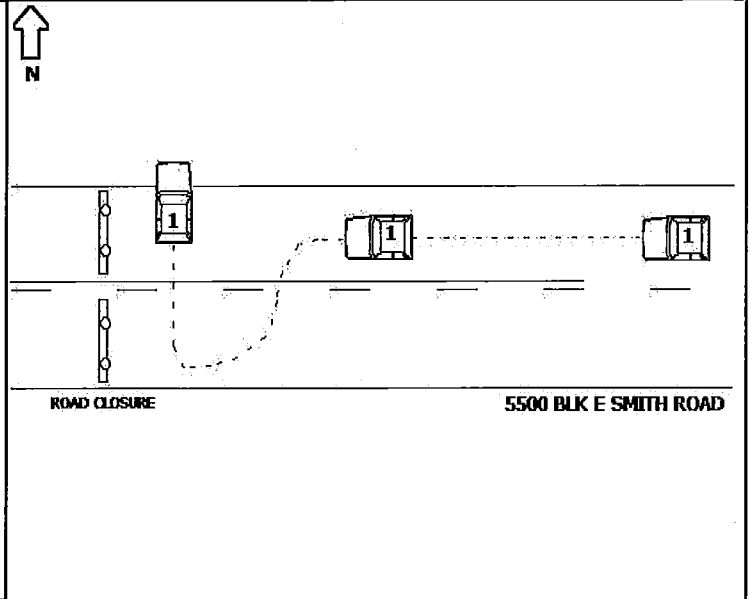

NARRATIVE

UNIT #1 WAS TRAVELING WEST ON E SMITH ROAD FROM RIVER STYX ROAD. UNIT #1 APPROACHED THE 3400 BLOCK OF E SMITH THAT HAD SIGNS WARNING MOTORISTS THAT THE ROAD WAS CLOSED AHEAD. UNIT #1 REACHED THE "ROAD CLOSED" SIGNS IN THE 3500 BLOCK AND ATTEMPTED TO TURN AROUND. UNIT #1 TURNED RIGHT TO BEGIN A U-TURN WHEN THE FRONT OF THE VEHICLE DROPPED INTO THE DITCH ON THE NORTH SIDE OF THE ROAD AND WAS NOT ABLE TO BE DRIVEN OUT. THE VEHICLE WAS WINCHED OUT BY PINNACLE TOWING. NO DAMAGE WAS REPORTED AND UNIT #1 WAS ABLE TO BE DRIVEN FROM THE SCENE. THE DRIVER OF UNIT #1 DID NOT REPORT ANY INJURIES AND WAS CITED WITH FAILURE TO CONTROL.
