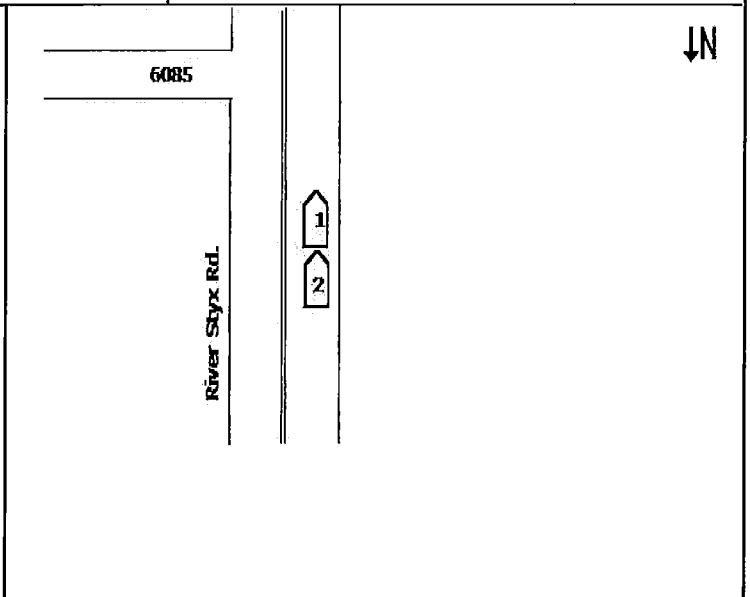

NARRATIVE  
Unit #1 was southbound on River Styx Rd., approaching Sharon Copley Rd., when it was forced to slow for traffic which was backed up from the intersection to the south. Unit #2, which was also southbound, crested the hill and did not have enough time to stop, striking Unit #1 in the rear. Unit #1 sustained moderate damage to the rear and Unit #2 sustained heavy damage to the front, requiring a tow for both vehicles. Unit #2's driver side airbag deployed; however, the driver did not claim and injuries or show any effects of the deployment. No injuries were reported at the scene. Both vehicles were towed from the scene, and the driver of Unit #2 was cited for ACDA.
