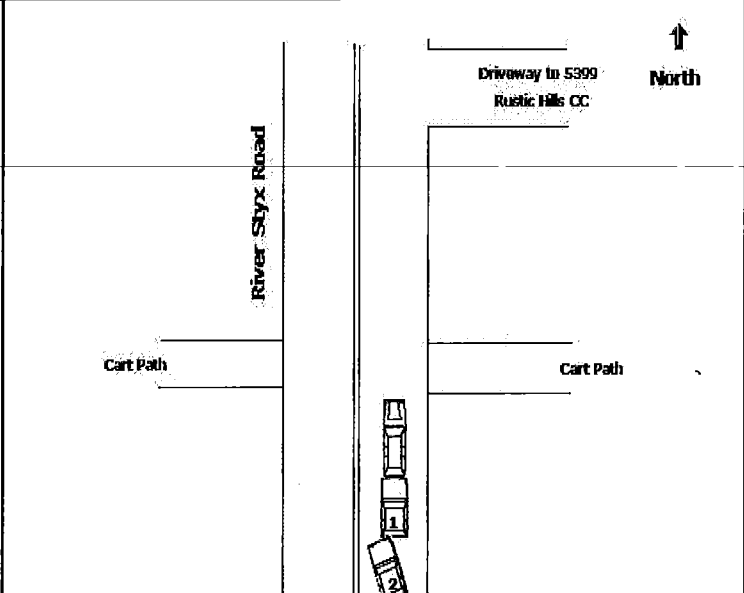



NARRATIVE

Unit #1 was northbound on River Styx Road when it was unable to stop for a vehicle stopped in front of it, and rear-ended that vehicle (See Report #160-13-10679). Unit #2 was also northbound on River Styx Road, behind Unit #1, and was unable to stop. Unit #2 rear-ended Unit #1. No injuries were reported and all occupants of both vehicles denied medical evaluation. Unit #1 and Unit #2 sustained functional damage in the accident. Unit #2 was driven from the scene, but Unit #1 was towed due to damage sustained in the first accident, where it rear-ended the stopped vehicle.
