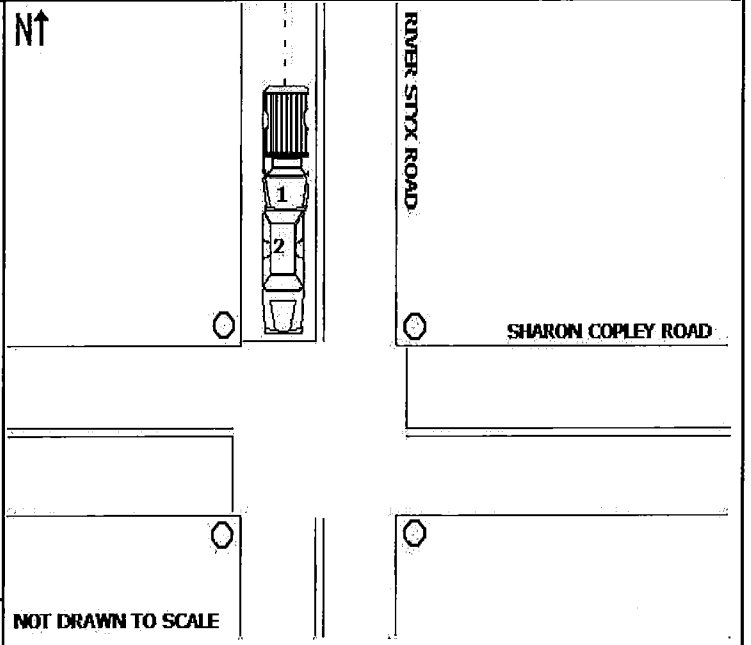

UNIT #2 WAS STOPPED IN THE SOUTHBOUND LANE AT THE STOP SIGN ON RIVER STYX RD AT THE INTERSECTION OF SHARON COPLEY ROAD. UNIT #1 PULLED UP BEHIND UNIT #2 TOO CLOSELY AND STRUCK THE REAR OF UNIT #2. BOTH VEHICLES SUSTAINED MINOR DAMAGE AND NO INJURIES WERE REPORTED. THE DRIVER OF UNIT #1 WAS CITED WITH ASSURED CLEAR DISTANCE AHEAD.
