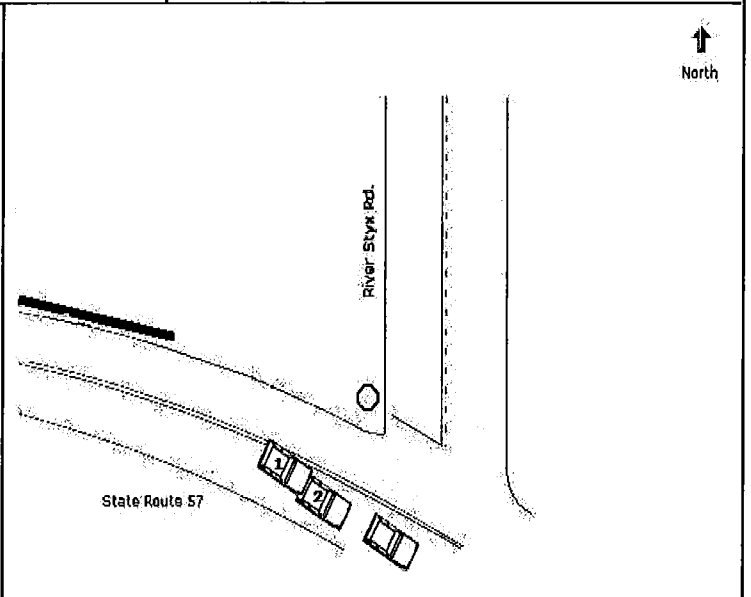

NARRATIVE

On 11/19/2013, Unit #2 was stopped in the southbound lane of Wadsworth Road awaiting the vehicle in front of her to turn onto River Styx Road. Unit #1 approached from the rear and stated he was distracted by looking at the flashing lights of the police cruiser on another call. Unit #1 struck Unit #2 causing minor damage to Unit #2, and disabling damage to Unit #1 requiring a tow. Minor injuries were reported by Unit #2's juvenile passenger, but medical assistance was denied by the driver.
