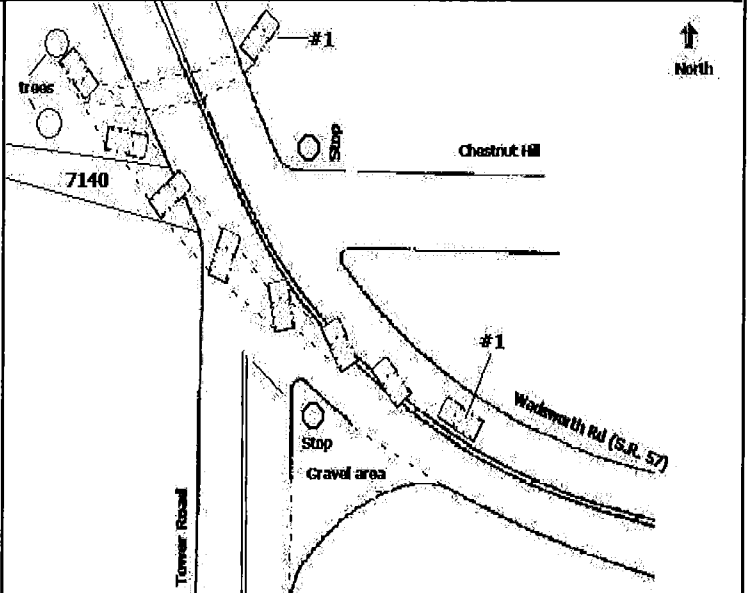

NARRATIVE

Unit #1 was northbound on Wadsworth Rd. in the area of Tower Rd. when the driver lost control while negotiating the curve in the roadway. Unit #1 began to spin out of control in a clockwise fashion, crossed the centerline, left the roadway and struck the mailbox post at 7140 Wadsworth Rd. As the vehicle continued to rotate, it struck a large tree with the rear center, causing severe rear damage. This impact also broke the driver seat rearward. Unit #1 then proceeded to drive away from the point of impact, crossing both lanes of travel and finally coming to rest in the opposite road ditch.

The owner of the damaged property at 7140 Wadsworth Rd., Ambrose Durham, stated that the driver tried to drive off several times. He also advised that she seemed disoriented, stating that she didn't know where she was or what had happened. Upon my arrival, the driver, identified as Christine Salsgiver, was asking where she was and did
