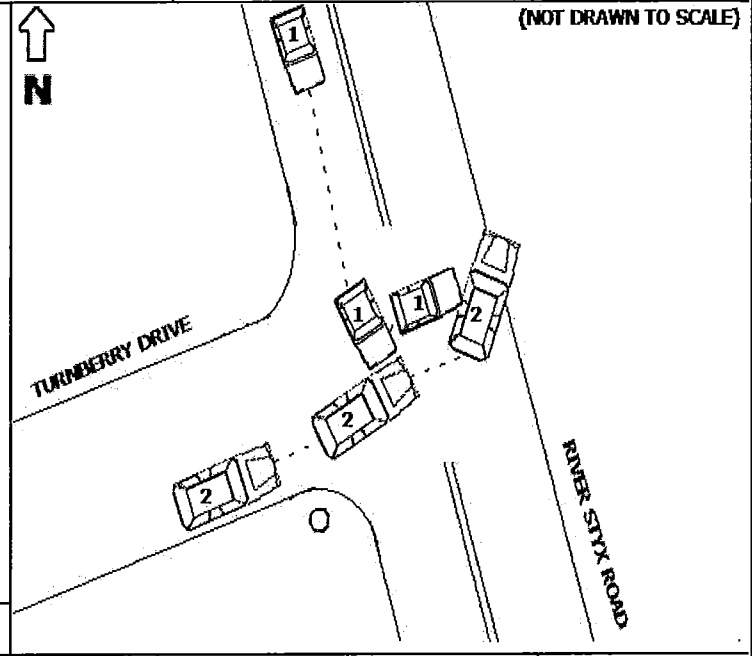

NARRATIVE

UNIT #1 WAS TRAVELING SOUTH ON RIVER STYX ROAD APPROACHING TURNBERRY DRIVE. UNIT #2 WAS TRAVELING EAST ON TURNBERRY DRIVE AND CAME TO THE INTERSECTION OF RIVER STYX ROAD. UNIT #2 PULLED OUT INTO THE INTERSECTION TO MAKE A LEFT TURN ON RIVER STYX IN FRONT OF UNIT #1. UNIT #1 WAS NOT ABLE TO STOP IN TIME AND STRUCK THE DRIVER'S SIDE OF UNIT #2. THE DRIVER OF UNIT #1 SUFFERED LACERATIONS TO HER FOREHEAD FROM STRIKING THE WINDSHIELD WITH HER HEAD. THE FRONT SEAT PASSENGER SUFFERED NECK INJURIES AND WAS NOT RESPONSIVE DUE TO HER DIABETIC ISSUES. THE REAR DRIVER'S SIDE PASSENGER SUFFERED SHOULDER INJURIES. ALL THREE OCCUPANTS OF UNIT #1 WERE TRANSPORTED TO MEDINA HOSPITAL BY MEDINA LIFE SUPPORT TEAM. THE DRIVER OF UNIT #2 DID NOT REPORT ANY INJURIES AT THE SCE
