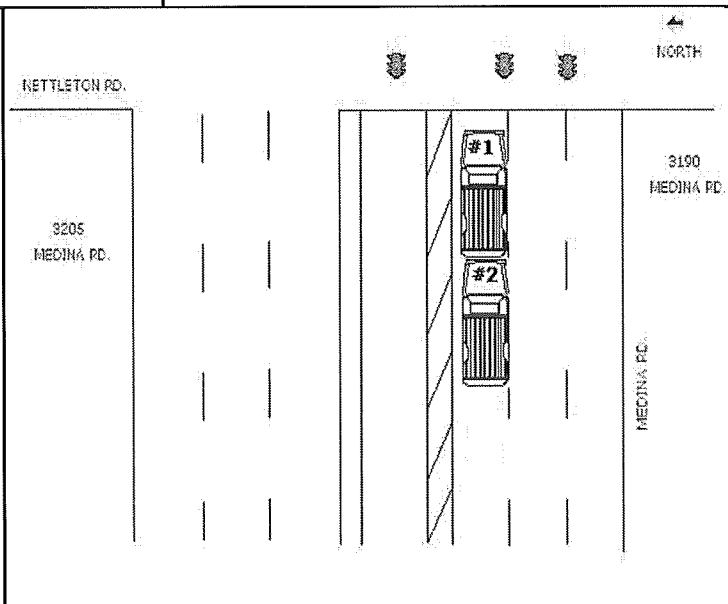


NARRATIVE

UNIT #1 WAS EASTBOUND ON MEDINA RD. AND STOPPED AT THE LIGHT NEAR THE INTERSECTION OF MEDINA RD. AND TRANSPORTATION DR. UNIT #2 PROCEEDED WHEN THE LIGHT TURNED GREEN AND STRUCK THE REAR OF UNIT #1, WHO WAS STILL AT A COMPLETE STOP. NO APPARENT DAMAGE WAS CAUSED TO UNIT #1, HOWEVER A BACKUP SENSOR SEEMED TO NOT BE WORKING AFTER THE CRASH. UNIT #2 SUSTAINED COSMETIC DAMAGE TO THE FRONT CENTER BUMPER AREA. BOTH VEHICLES WERE ABLE TO BE DRIVEN FROM THE SCENE. NO INJURIES WERE CLAIMED BY EITHER PARTY.
