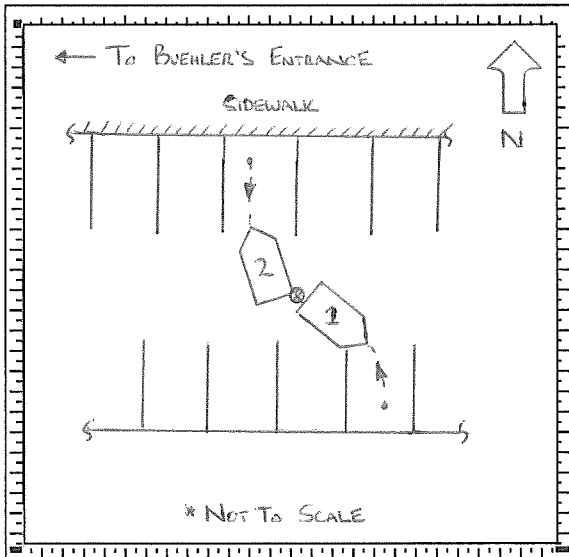

### Narrative

On 4/16/2013, John Gormley arrived at the Montville Police Department around 4:30 pm, to report a private property crash that had occurred around 12:00 pm. According to Mr. Gormley, after backing out of a parking spot in the Buehler's parking lot, and beginning to travel forward, his vehicle was struck in the passenger side rear bumper by another vehicle that was backing out of parking spot behind him. The other driver and female passenger exited their vehicle and after a short verbal confrontation with Mr. Gormley, left quickly without providing any of their information. Mr. Gormley was unable to get a license plate number off of the vehicle as it left the scene. Upon arrival at the Montville Police Department, Mr. Gormley's vehicle had damage to the right passenger side rear bumper. The identity of the other driver and passenger is unknown, although Mr. Gormley believed the other vehicle to possibly be a gray Pontiac Bonneville. Buehler's Security was unable to find Mr. Gormley's vehicle in the parking lot on video or any video showing the incident. (The drawing was completed based on Mr. Gormley's statements only.)
