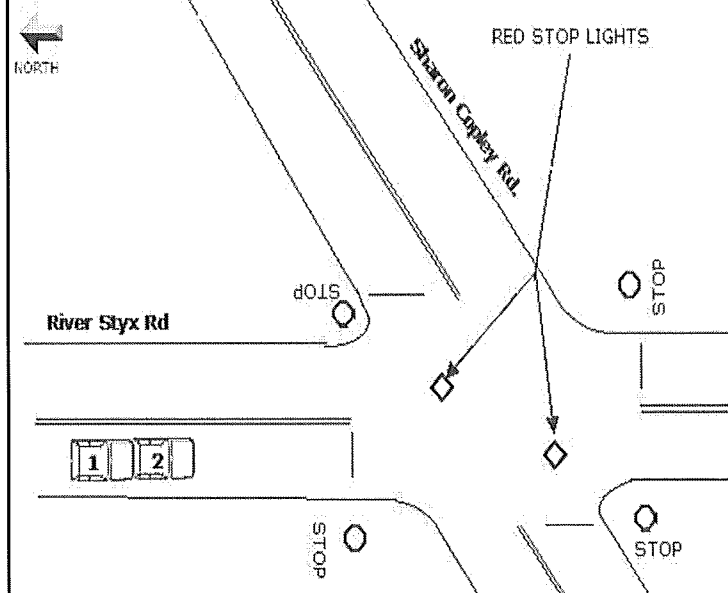

UNIT #2 WAS STOPPED IN TRAFFIC WHILE SOUTHBOUND ON RIVER STYX RD AT THE INTERSECTION OF SHARON COPLEY RD (S.R. 162). UNIT #1 WAS ALSO SOUTHBOUND ON RIVER STYX ROAD AND FAILED TO STOP IN TIME, STRIKING UNIT #2 IN THE REAR. NO ONE WAS INJURED IN THE ACCIDENT, BOTH VEHICLES SUSTAINED MINOR DAMAGE, AND WERE DRIVEN FROM THE SCENE.
