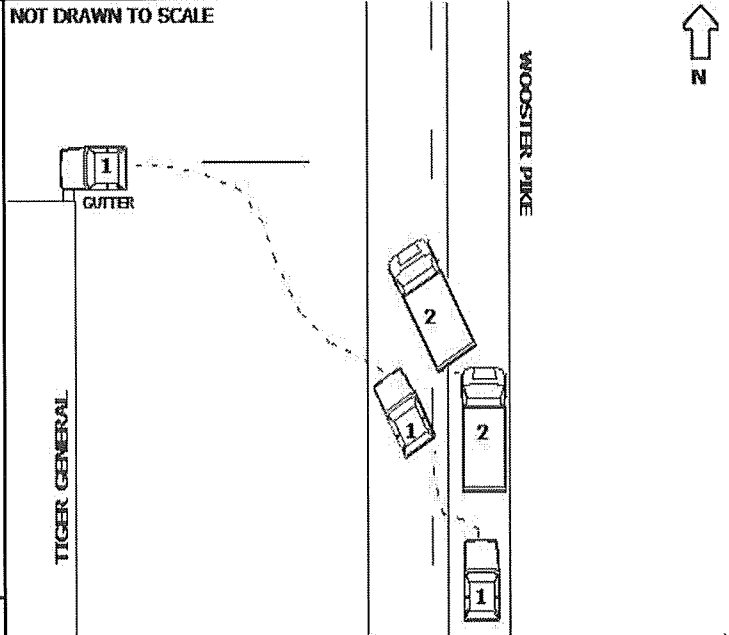



NARRATIVE


