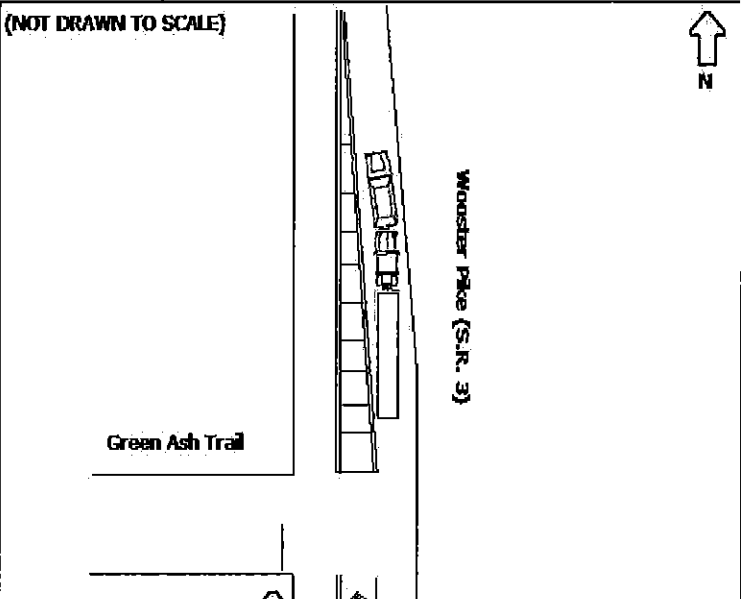

NARRATIVE

UNIT #1 WAS TRAVELING NORTHBOUND ON WOOSTER PIKE (SR 3) BEHIND UNIT #2. THE VEHICLE IN FRONT OF UNIT #2 STOPPED SUDDENLY CAUSING UNIT #2 TO SLAM ON HER BRAKES. UNIT #1 WAS NOT ABLE TO STOP FAST ENOUGH AND REAR ENDED UNIT #2. UNIT #1 IS A TRACTOR TRAILER HAULING OIL FOR VARIOUS MOTOR COMPANIES. NO HAZARDOUS MATERIALS WERE RELEASED OR WERE BEING HAULED. THE DRIVER OF UNIT #2 CLAIMED TO BE SORE IN HER RIGHT ARM AND WAS ALSO SIX MONTHS PREGNANT. SHE WAS TRANSPORTED TO MEDINA HOSPITAL TO HAVE HER INJURIES EXAMINED. THE DRIVER OF UNIT #1 WAS CITED WITH ASSURED CLEAR DISTANCE AHEAD.
