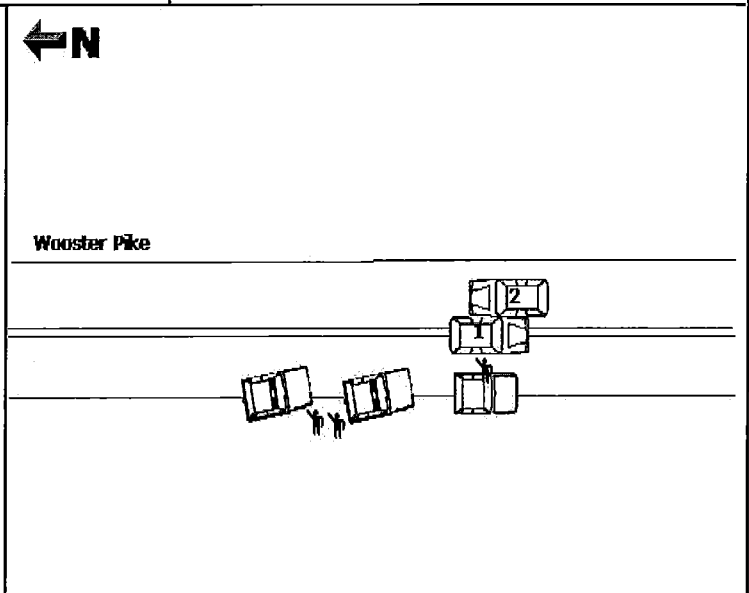

NARRATIVE

While assisting P.O. Justin Bennett on a traffic stop on Wooster Pike, just south of High Point Dr., I witnessed Unit #1 overtake our two fully marked patrol units and collide with an unknown northbound vehicle which did not stop despite being damaged.

P.O. Bennett's cruiser and the vehicle he had stopped were in the southbound lane of Wooster Pike, just south of High Point Dr. This area has a solid yellow center line in both directions. After he asked for another unit, I arrived and pulled directly behind P.O. Bennett's cruiser. Both patrol units were slightly on the shoulder and slightly canted for officer safety. Both fully marked patrol units had all of their fully operational red and blue LED lights in the on position. I stood outside the vehicle with the driver of P.O. Bennett's traffic stop and watched both him as well as traffic while P.O. Bennett conducted a search of the vehicle after detecting the presence of marijuana.
