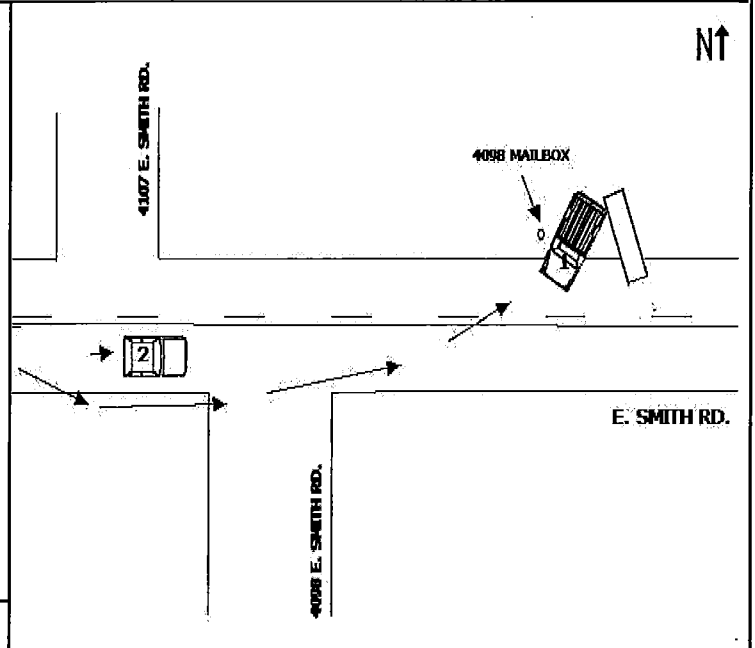

NARRATIVE

Unit #1 was pulling a trailer (OH Reg. TPZ3130) with a mini track hoe on it. Unit #1 was also traveling East on Smith Rd. Unit #2 pulled onto Smith Rd. in front of Unit #1 causing Unit #1 to swerve off the right side of the roadway in front of 4108 Smith Rd. Unit #1 returned to the roadway and was attempting to stop; however, the rear end of the vehicle rotated counter clockwise due to the trailer. Unit #1 jack-knifed and went of the left side of the roadway running over mail box number 4098 and turving the front yard of 4108 before coming to final rest. Unit #1 sustained damage from it's trailer jack-knifing and striking it in the process. Unit #2 was not damaged and no one was injured in the accident.


