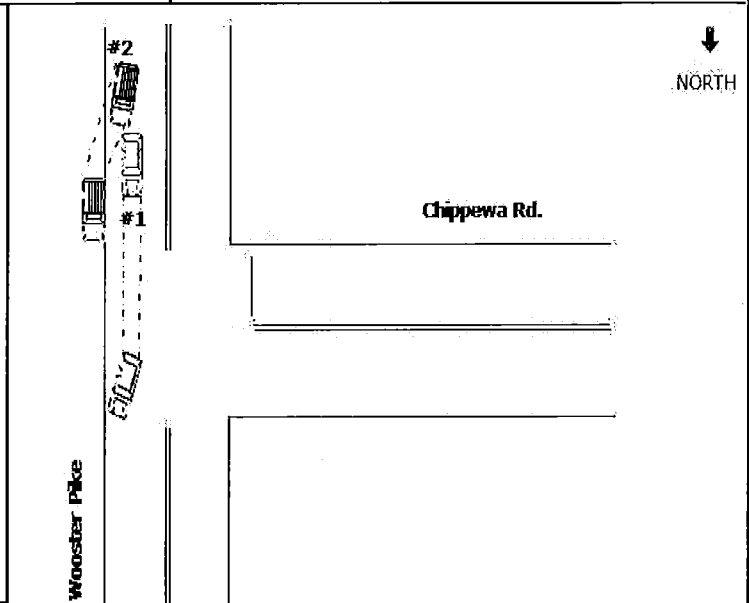

NARRATIVE

Unit #1 was northbound on SR 3 (Wooster Pike) and was slowing for vehicles which were slowing and/or turning west onto Chippewa Rd. Unit #2 was also northbound on SR 3 (Wooster Pike), directly behind Unit #1. The driver of Unit #2 stated that when he applied his brakes to slow down for the slowing traffic, they seemed to malfunction initially. He stated that they started to work, but were "pulsating", not allowing the truck to slow quickly enough to avoid impact. The driver of Unit #1 stated that he tried to "turn away" from Unit #1 but ended up striking it in the rear, sending it just through the intersection.

Unit #2 then went off the right side of the roadway and came to rest in a ditch. Unit #1 moved off the roadway under its own power prior to my arrival. Shue's towing recovered Unit #1, while World Truck recovered Unit #2. No injuries were claimed at the scene. The driver of Unit #2 was cited for ACDA.

Unit #1 was northbound on SR 3 (Wooster Pike) and was slowing for vehicles which were slowing and/or turning west onto Chippewa Rd. Unit #2 was also northbound on SR 3 (Wooster Pike), directly behind Unit #1. The driver of Unit #2 stated that when he applied his brakes to slow down for the slowing traffic, they seemed to malfunction initially. He stated that they started to work, but were "pulsating", not allowing the truck to slow quickly enough to avoid impact. The driver of Unit #2 stated that he tried to "turn away" from Unit #1 but ended up striking it in the rear, sending it just through the intersection.
