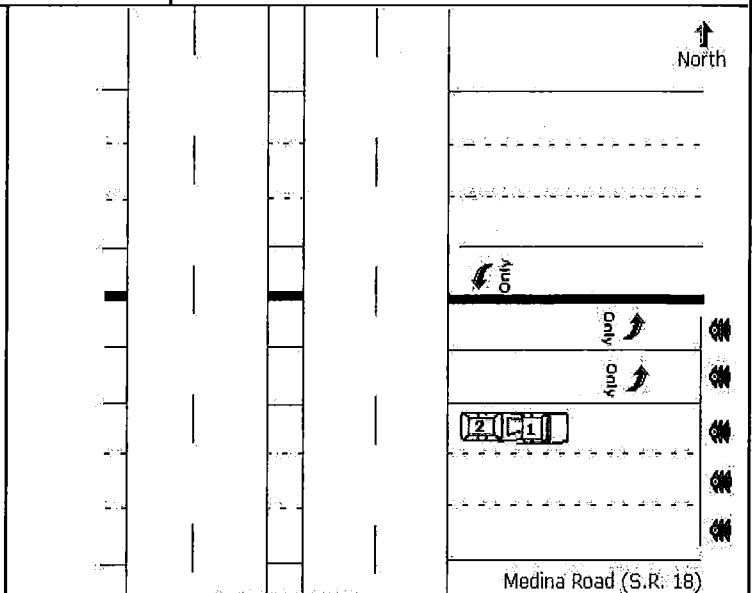




**NARRATIVE**

Unit #1 and Unit #2 were both eastbound on Medina Road (S.R. 18) near the overpass of I-71. Unit #2 was directly behind Unit #1 and when Unit #1 stopped in traffic, Unit #2 failed to stop in time, and struck the rear of Unit #1. Neither driver was injured in the accident. Unit #1 sustained functional damage and Unit #2 sustained only minor visible damage. Both vehicles were driven from the scene.

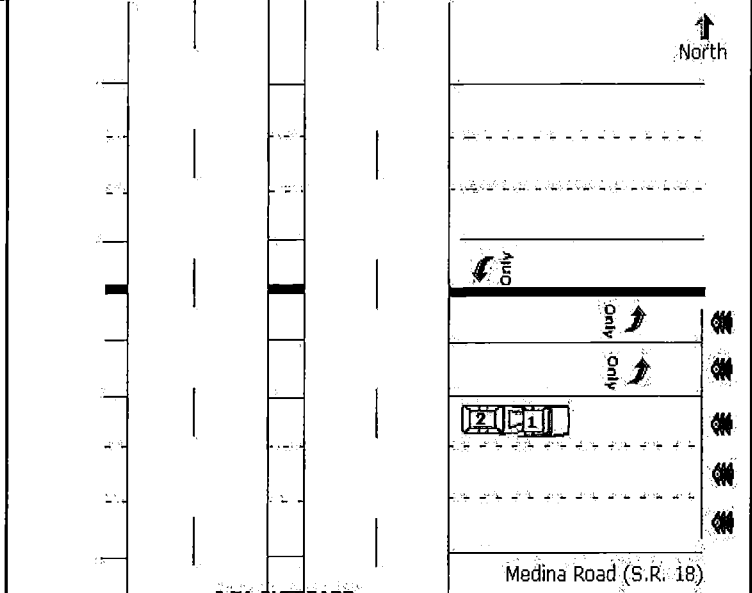
